



## **Memorial Park Municipal Swimming Pool Rules and Regulations**

All persons must observe these rules and regulations with the understanding that should circumstances warrant, we may cancel any membership at this facility. Due to safety reasons we also reserve the right to limit the number of persons in the pool.

- **The use of the pool is at your own risk!**
- **All persons must check into the pool sign-in book**
- **Only persons who have registered may use the pool**
- **Membership cards must be present at the time of arrival**
- **Membership may not be transferred**
- **All persons wishing to use the pool must register prior to use of the pool**
- **We are not responsible for lost, broken or stolen items**
- **All trash must be placed in the proper trash receptacle**
- **No smoking in the pool area or on Park grounds**
- **Alcohol or drug impaired persons will not be permitted in the pool area**
- **Pets are not permitted in the pool area**
- **Persons with infections or diseases that may be transmitted by the pool water are prohibited (28 PA Code 18.53)**
- **Persons with diarrhea are prohibited from using the pool**
- **Urinating and releasing of any other bodily fluids in the pool is prohibited**
- **Children in diapers must use rubber pants, swimming diapers and swim suit**
- **Children must be taken on bathroom breaks and diapers checked often**
- **Change diapered children at the provided stations in locker room only**
- **Persons should shower before entering the pool**
- **Spitting water is prohibited**

## **Memorial Park Municipal Swimming Pool Rules and Regulations**

- **Running, roughness, pushing and dangerous ball playing are not allowed**
- **Feet first entry into the shallow end**
- **Glass and other breakable objects are prohibited in pool area**
- **Proper swimming attire only**
- **Pool will be cleared every hour**
- **All children under the age of 14 must be accompanied by an adult**
- **If you are bringing a group of children under the age of 14 there must be one adult for every 5 children\***
- **Failure to abide by any and all pool rules may result in ejection from the pool and membership revoked for the remainder of the season**
- **The City of Chester Department of Recreation may make any additional rules and regulations necessary to ensure the health and safety of the swimmers**

## CONSENT FORM

As a condition of my and my child(ren)'s (if applicable) use of such services, facilities, swimming pool and or programs, I on behalf of myself, my heirs and assigns and my child(ren) (if applicable) expressly agree to forever discharge, waive and release the Department of Parks, Public Property and Recreation, the City of Chester, management, staff, servants, agents, employees and/or independent contractors and their heirs, successors and assigns from any and all claims, demands, injuries, damages, actions, or courses of action, and from all acts of active or passive negligence on the part of the Department of Parks, Public Property and Recreation, the City of Chester, management, staff, servants, agents, employees and/or independent contractors that I or my child(ren) (if applicable) may have or acquire against the Department of Parks, Public Property and Recreation, the City of Chester, management, staff, servants, agents, employees and/or independent contractors and their heirs, successors and assigns on account of bodily injury, mental injury and/or property damage from, any mishap, accident, loss, damage or injury suffered by my child(ren) (if applicable) or myself or others resulting from, connected with or caused by the use of the Department of Parks, Public Property and Recreation's services, programs, swimming pool and/or facilities, including, but not limited to any injury resulting from mechanical defects or failure of any equipment or devices used in such services, programs, swimming pool or facilities. I further agree to defend, indemnify and hold harmless the Department of Parks, Public Property and Recreation, the City of Chester, management, staff, servants, agents, employees and/or independent contractors and their heirs, successors and assigns from any and all claims, losses or liability arising from, connected with or caused by my or my child(ren)'s (if applicable) use of the Department of Parks, Public Property and Recreation's services, programs, swimming pool and facilities.
3. I declare and affirm that I and my child(ren) (if applicable) am (or are) in good medical and physical condition and that the use of the Department of Parks, Public Property and Recreation
