I did hear at the previous City Council Meeting, that the property located at 2405 Chestnut Street has been put on the demolition list with the County. I want to extend my deepest gratitude to all the City Officials involved in assisting my household and our community to remove this blighted property. Huge thanks to Mr. Michael Gilante for filing paperwork to expeditiously move this process forward. Thank you, Mr. Walker, who came out and posted the condemned sign on the property.

I reflect on the many positive words spoken at the swearing in ceremony January 6, 2020. From Councilman William Morgan who wants to make sure we keep sailing the boat in the right direction to Councilwoman Elizabeth Williams who lived in Chester all her life, worked hard and stated we are going up; as well as Mayor Kirkland who acknowledged that he was blessed with the very best team of Elected Officials that anyone could hope for. I find comfort in Mayor Kirkland's sentiments that everyone is working on the behalf of each and every citizen of the City of Chester. Team Work Makes the Dream Work - agree 100%. There is a commitment to making Chester the best/#1 city, not just in the Commonwealth of PA, but throughout the US. I will do all I can, as a Chester resident, to assist in these goals.

As my husband and I continue to endure raccoons getting into our property (front room ceiling - front bedroom flooring and porch roof), we hired the Delaware County Animal control for trapping. Since November 4th, they have trapped 13 raccoons. It's \$46.80 each time they remove a trapped raccoon and re-bait, in addition to \$159.99 for initial set-up. This is a financial hardship, but we have no other option. It's unbearable to sleep at night hearing constant rustling of raccoons in my bedroom floor, but I know my city officials are working hard to eradicate this nuisance property. Is there any way to know when this property would be demolished. Is it 3 to 4 months from it being mentioned at the previous Council meeting or a later date?

Please forgive me for my eagerness if it seems excessive, we will continuing to be patient as you do all you can.
