## MEETING OF THE COUNCIL OF THE CITY OF CHESTER

A regular meeting of the Council of the City of Chester was held on the above date at 10:00 AM with Mayor Kirkland presiding. A prayer was said followed by the Pledge of Allegiance. The roll was called and the following were present:

On motion of Councilor Morgan, seconded by Councilor Williams, the minutes of the previous meeting were approved with correction and submitted. The following vote was taken: Yeas: Williams, Morgan, Roots, Mayor Kirkland Nays: 0.

Councilman Morgan made a motion to amend the current agenda to add Resolution 11 Authorize approval for the adoption of city-wide deteriorated boundaries.

Ken Shuster, City Solicitor said, the purpose of amending the agenda was due to a public hearing this morning to determine the boundaries that was not put on the agenda 24 hours before the council meeting.

Mayor Kirkland asked for public comment on agenda items only.

Mayor Kirkland said, the Philadelphia Union has been a great partner and friend to the City from day one; they have embraced our community and helped it grow. When others

would say that Chester's not doing this and Chester's not doing that, the Philadelphia Union has invested 55 million dollars into a development at the soccer stadium to help the City to continue to grow and create jobs. This is more than a partnership it is a friendship. We don't just give out keys to the City just willy nilly, but we give them out to persons, organizations and individuals that truly have the best interest of Chester at heart and they show it by their actions. On behalf of Mayor and Council, he thanked them for all that they do in the City of Chester; they're champions! He said, they may be the Philadelphia Union but they are the Philadelphia Union located in Chester.

Councilman Roots said, it's interesting that we are giving them the key to the city because they already act like they have the key to the city. They're in so many areas of our city doing great work. He wanted to thank them personally.

Councilman Morgan said, he has had a number of meetings with the Philadelphia Union about initiatives, projects, and recreational activities. He said, he was reached out to, to become a part of the Philadelphia Union Foundation; the IAm project. He said, it is a project that the union has rapped their arms around and created to assist with students; bringing them on college tours. They also bring in speakers such as Rich Kliman, a manager of Kevin Durant. Councilman Morgan said, they have had their finger prints on the children in Chester in a positive way to give them exposure that many of our children may not see. He thanked them for what they do.

Mayor Kirkland presented Tim McDermott and Dave Debusschere the key to the City on behalf of the Philadelphia Union.

Councilwoman Williams commented about April Zviello persevering in her quest to become a Chester firefighter. She encouraged women to choose a career in becoming firefighter.

Councilman Roots said when he met with the firefighters, he said he asked them why they chose Chester to launch their careers. He asked each firefighter to introduce themselves and say a few words to the community.

Each firefighter expressed their gratitude to Mayor and Council, Commissioner Rigby and their families for their support.

#### **Public Comment**

Anita Littleton had a follow up concern about the abandoned houses on 9<sup>th</sup> St. across the street from Chester High School. She wanted to know what was going to be done about those houses. She asked, are taxes being paid om them as to the reason why abandoned houses can remain there. Also, an abandoned car has been sitting in front of her home since November. She has called several times. She asked, what is the turnaround time before the car is removed? Also, what is the continued plan to clean up illegal dumping?

Mayor Kirkland asked Mike Galante, City Engineer to speak to abandoned houses concern.

Mike Galante said, we are working with the county with the priority list. Those homes are not on that list. I will get the addresses to see if they can be put on the demo list if it's something that need to happen. He said he would talk to her after the meeting.

Councilman Morgan said, he will check to see if those properties taxes are current; or if a payment plan is set up with Delaware County. He said, we want owners to keep up with the upkeep of the properties. We are working on ordinance and legislation to hopefully mitigate that in the future. We are doing assessments with L&I, code enforcement and looking at other municipalities and cities to see what laws they have enacted to decrease the amount of time that a property can stay vacant and or blighted to a community like those have been.

Anita Littleton asked, what is enacted now with those situations? What is the time frame? Is there anything in place for when properties are abandoned?

Councilman Morgan said, not anything that's outside of our normal ordinances for public safety, L & I, code enforcement, reaching out to those property owners and citing them on an as needed basis.

Mayor Kirkland asked Commissioner Gretsky to speak on the abandoned car issue.

Commissioner Gretsky said, he will go take a look at the abandoned car Anita Littleton spoke about. Working with COO to transfer the abandoned vehicles to L&I. There is a process to tag ad tow in 72 hours.

## Mayor Kirkland asked Commissioner Gretsky to speak on the arrest made in regard to illegal dumping.

Commissioner Gretsky said, they have come up with a taskforce; I&I, DA, CID and himself. They have portable cameras and a it's put on the Facebook page which helped them to make an arrest.

Mayor Kirkland said, we are in the process of cleaning up as many dump sites as possible. He asked the community if they would be vigilant when it comes to looking out, because, as fast as they are cleaning them up, if there's no camera there, they are back dumping again. There not dumping at night now; they're dumping during the daytime, so we need the help of our residence as well.

Anita Littleton asked, what are some of the criminal charges? What are the consequences of illegal dumping?

Commissioner Gretsky said, in reference to arrest, there is due process, a lot comes on the judges, a fine, taking the persons vehicle, it goes through the court system.

# Councilman Morgan said, a member of L&I will speak to you about their meet and greets that they have.

Brown Williams asked about having to pay stormwater and sewage? Chester is the poorest city in the country. He said our young black men don't have opportunities in the city.

Mayor Kirkland said, Chester is not the poorest city in the country. He said, Mr. Brown, we don't' have Sun Ship anymore, we don't have a Ford Motor Company anymore. We would love to have those company's here, but we don't have them. Our young black men have opportunities here in this city for employment. There's going to be great opportunity down at the soccer stadium; 55 million dollars investment. Someone will need to come in and help build that facility. You saw today all those firefighters being sworn in and we have police officers that will be sworn in. We plead with our residents to come after those career opportunities; to say that there's nothing to do and they can't get these jobs and opportunities. That's not correct. Those opportunities are there. We fight every-day for Chester residents to apply to get jobs within this city government. All it takes is to have the skill set to do the job. If residents choose not to come and choose not to work, that is not the fault of this government; that is the fault of that individual. We welcome those persons to come to say they want to be a police officer or firefighter; I want to work in city government, I want to go down to the soccer stadium and show them my worth, I want to go down to Harrah's and show them my worth, I want to go to Silvercare Health Services and show them my worth. Those opportunities are there.

Mr. Williams said, if they get caught with in the street with reefer, they will be told that they have a background. They will not hire them. He asked Mayor Kirkland, if I bought 25 people here for jobs, would you hire them?

Mayor said, no. I say that because we don't have 25 jobs, but if we had 25 jobs that were available in city government and they are qualified for those positions, we'd put them to work.

Mr. Williams spoke about the Stormwater Authority only being in the City Chester, houses being striped and should have a dumpster. He said, there is trash everywhere. He said, when the police stop people they tow the car to Iacona and charge 5 and \$600.00 dollars. He said, someone shot out his window to his house and the city should fix his window.

Mayor Kirkland said, there are stormwater authorities throughout Pennsylvania; not only Chester but in other states. The Stormwater Authority was established by the state legislature to elevate flooding within our communities. He said, in reference to the towing, they do not charge 5-\$600.00 per day; that is not true. Mayor Kirkland said, the city should not fix the window; it's called homeowner's insurance.

There being no other business to come before Council, the meeting was adjourned at 11:45 AM.
